Sealed Offers will be opened on **15 October, 2019 (Tuesday) at 11:00 hours** in the presence of available participants at Federal Ombudsman Secretariat for Protection against Harassment of Women at Workplace (FOSPAH), 1st floor, LG and RD Complex, Behind State Bank of Pakistan, Sector G-5/2, Islamabad.

3. The Terms and conditions of auction are as under:

- a) The participants will submit deposit at call in favour of DDO, Federal Ombudsman Secretariat for Protection against Harassment of Women at Workplace (FOSPAH), Islamabad, worth Rs.5,000/- (Re-fundable) for participation in auction.
- b) The bidder offering highest rate will deposit 25% of the total auctioned amount on the same day and remaining amount will be deposited within three days, in case of failure 10% of total value shall be charged as rent/penalty.
- c) If successful bidder fails to take away auctioned items within 30 days, 100% of deposit at call and deposited amount of 25% shall be forfeited in favour of Government of Pakistan.
- d) The FOSPAH employees are not allowed to participate in the Auction process.
- e) The successful bidder will pay all the prevailing Government Taxes / duties as admissible under the rules.
- f) Auctioned partitions will be handed over after making full payment.
- g) In case of any dispute, the Federal Ombudsman, FOSPAH, Islamabad will be the final authority.
