	30-05-2022	<p>Complaint No. <u>FOH-HQR/0000067/2022</u></p> <p>As per revenue record placed on the file the complainant Khaira Bibi widow of Muhammad Sadiq is recorded owner of 1 kanal 8 marla land situated in Moza Kot Hathiyal, Bhara Kahu, district Islamabad. The complainant alleges that she has been deprived off her ownership and possession of the property by her nephews Amir Zaman & others who have illegally possessed and occupied that land and are also threatening and abusing her.</p> <p>Respondents Amir Zaman and his other brothers were summoned to clear their position but they remained absent despite issuing them several direct notices as well as through SHO PS Bhara Kahu. They were therefore placed ex-parte. Complainant examined Muhammad Naveed, Muhammad Ashfa, Gul Khitab and Pervaiz Akhter as her witnesses pertaining to their affidavits ex PW 1/1, ex PW 2/1, ex PW 3/1 and ex PW 4/1 respectively. All the witnesses deposed that the suit property is the ancestral property of the complainant which has</p>

been illegally possessed by Amir Zaman & others. They further submitted that respondent Amir Zaman and his other brothers participated in several jirgas of the village but they refused to listen to the jirgas. Complainant appeared as PW 5 and reiterated her stance that she is owner of land measuring 1 kanal 8 marla situated in new abadi Moza Kot Hathiyal, Bhara Kahu Islamabad which has been illegally occupied and possessed by her nephews Amir Zaman & others who are threatening to kill her and are bent upon to quarrel with her every time.

In view of the above facts the complainant has made out her case. Hence in the given circumstances I find that complainant has been illegally deprived of ownership or possession of the property. Therefore while invoking section 5 of the Enforcement of Women's Property Rights Act 2020, I direct Deputy Commissioner Islamabad to take steps so as to restore possession of the property in question to the complainant and after doing the needful to submit compliance report within 7 days to this forum in respect of implementation of the above order.
