  - ii. Pre-qualification documents will be opened on the above mentioned date at 03:00 P.M under the supervision of the Chairman Purchase Committee and purchase committee members.

## **TERMS & CONDITIONS**

- i) The firms on the panel shall be bound to carry out the requisite work at the earliest when repairs are referred to them even at odd hours/ public Holidays while ensuring quality and timely service in a transparent manner as and when required in accordance with all applicable laws, rules and regulations.
- ii) While submitting rates the Firms must clearly mention GST and all other applicable Government Taxes included in the offered rates or otherwise.
- iii) The Firms shall be bound to return old spare parts in case of replacement with the new ones.
- vii) Each Firm/vendor is required to nominate a Focal person along with full contact detail, for coordination and immediate response.
- viii) Affidavit for non-blacklisting of the firm/vendor would be provided on stamp paper/ affidavit amounting to Rs.100/-.
- ix) Agreement will be signed with the successful bidder for provision of said services in the light of all applicable, laws, rules and regulations, whose compliance will be ensured in any case by the bidder till its expiry.
- x) Firms should have their own state-of-the-art office/workshop with proper tools/equipments at Islamabad/ Rawalpindi.
- xi) Firms must have General Sales Tax Registration, National Tax Number and is on active taxpayer list (ALT) of FBR. The firm should have bank account and vender number assigned by AGPR.
- xii) For prequalification, firms having experience, capability and resources may apply along with the following information and documents: -
  - a) Name of the firm along with postal address, Phone & Fax numbers.
  - b) Similar nature of works completed during last One year.
  - c) List of Key personal & detail of Technical staff.
  - d) Affidavit for nor blacklisted/involved in arbitration/litigation with any client.
- xiii) The firms will be shortlisted as per PPRA Rules 2004.
- xiv) Successful firms shall be responsible to provide its services for repair/maintenance after approval of their quotation during the whole year.
- xv) Firms shall respond on receipt of work order at the earliest.
- xvi) Firms shall preferably make it possible to rectify the fault of certain mechanical problem at the spot otherwise at workshop at their own arrangement.
- xvii) Pre-qualification of firms will be processed in light of clause 15 to 19 of PPRA Rules, 2004.

xviii) Only pre-qualified firms/companies/workshops will be eligible to do business with FOSPAH Secretariat during the financial year 2025-26 & 2026-27.

## **MARKING CRITERIA:**

The marking criteria for pre-qualification of Firms for repair/maintenance of Machinery & Equipments is as under:

- i) The interested Firms must have One (01) year' experience in relevant field. The firm/vendor having experience shall be awarded 2 marks per year, maximum up to 5 years. Experience beyond 5 years will also yield maximum 10 marks. **(10 marks)**
- ii) The Firms shall provide details of Federal Provincial Government Ministries / Divisions/Departments to whom, they have provided or providing services of same nature. **(5 marks)**
- iii) The Firms must have their own complete setup i.e. spare parts availability and technical expertise in Islamabad & Rawalpindi having Telephone/ Fax facilities etc. in order to provide quality and timely service as per requirement in accordance with all applicable laws, rules and regulations. **(15 marks)**
- iv) The Firms must be registered with Sales Tax and Income Tax Department (FBR). The firm/vendor must be GST/NTN registered and should be Active Sales/Income Tax payer. **(5 marks)**
- v) The interested parties must have sound financial position; proof may be provided for last One (01) year in shape of income tax and company bank statement. **(5 marks)**

**Note: The Firm/Vendor/Workshop obtaining marks less than 50% will not be considered for prequalification.**

## **INSTRUCTIONS:**

- i) Conditional, incomplete and non-compliance to terms and conditions of bidding documents and over writing/cutting in documents shall not be accepted.
- ii) Any document received after the specified submission date and time mentioned in this document shall not be considered and it will deem to have been rejected.
- iii) Member(s) of Purchase Committee may visit of all Firms, before the pre-qualification.
- iv) List of Names and Telephone numbers of their technical teams with their experience and name of Focal Person shall be attached.
- v) This shall be the responsibility of the successful firm/ bidder to have secure custody/keeping of the official Items, in case the same are transported to the bidder facility/office. If any damage occurred in that case, the bidder shall bear all expenditures.
- vi) The workshop on the panel shall be bound to carry out the requisite repairs & maintenance on top priority basis whenever work is referred to them.
- vii) If a bidder is unable to fix the items, as per work order, then the firm would be backlisted for future business with the Government Departments through PPRA.
